Pentagon Backtracks on TRICARE Fee Hikes

When Under Secretary of Defense (Personnel and Readiness) Dr. Clifford Stanley called a meeting with MOAA President VADM Norb Ryan, Jr. (USN-Ret) and other association leaders on Feb. 14 to outline the TRICARE fee proposals included in the new FY2012 Defense budget, the bottom line of his briefing was, "We listened."

The new plan entails no changes for TRICARE Standard or TRICARE For Life, and no means-testing of fees. It proposes what Stanley described as "modest, gradual" changes in TRICARE Prime enrollment fees, and would exempt military disability (chapter 61) retirees and survivors from those changes. Specifically, the plan calls for:

- Raising the 2012 Prime enrollment fees by 13% -- from \$230 single/\$460 family per year to \$260/\$520 (survivor and chapter 61 retiree fees would remain at current rates)
- Indexing those fees in 2013 and beyond to a medical inflation index (based on a measure of Medicare cost growth projected to rise at 6.2% per year)
- Changing TRICARE pharmacy co pays as follows (changes indicated in parentheses):

MOAA is encouraged that the new proposal avoids the draconian TRICARE fee increases proposed in the past. While some areas warrant additional adjustment, it makes a better effort to recognize that career military people pre-pay a very large price for their lifetime health coverage up front – through decades of service and sacrifice. MOAA strongly supports the proposed elimination of co-pays for use of generic drugs via TRICARE's Home Delivery (mail-order) program and appreciates that survivors and medically retired personnel would be exempt from the proposed Prime increases.

However, MOAA objects strongly to the proposed annual adjustment methodology that would inappropriately tie fee increases for non-disabled military beneficiaries aged 38 to 64 to healthcare cost growth for a more elderly and disabled Medicare population. MOAA believes, in recognition of military beneficiaries' lengthy service and sacrifice, any such adjustments should be capped closely to the percentage increase in their military compensation.

VA Urges Veterans to Sign Up for Direct Deposits
Treasury Publishes Final Regulation to Phase Out Paper Checks by 2013

WASHINGTON - The Department of the Treasury announced a new rule that will extend the safety and convenience of electronic payments to millions of Americans and phase out paper checks for federal benefits by March 1, 2013. Officials at the Department of Veterans Affairs (VA) urge Veterans to sign up for electronic payment of their benefits.

"Receiving VA benefits electronically will increase the security, convenience and reliability of these vital payments," said Secretary of Veterans Affairs Eric K. Shinseki. "VA encourages Veterans who are now receiving their benefits in paper checks to set up direct deposits before the deadline."

On March 1, 2013, VA will stop issuing paper checks. People who do not have electronic payments for their federal benefits by that time will receive their funds via a pre-paid debit card. Called the Direct Express card, it is issued by Comerica Bank as the financial agent of the U.S. Treasury. Along with payments for VA benefit, the change will also affect recipients of Social Security, Supplemental Security Income, Railroad Retirement Board, and Office of Personnel Management.

Another deadline affects people receiving VA's compensation or pensions for the first time after May 1, 2011. Those people will automatically receive the benefits electronically. Anyone already receiving federal benefit payments electronically will be unaffected by the changes. 2012 NH MOAA Travel Program

Our 2012 Travel Program opens in May with a 13 day **Alaska Discovery** trip. This trip starts in Fairbanks with a cruise on the Stern Wheeler **Discovery**. We then go to Denali National Park for 2 days. The **Denali Express** train takes us from Denali to Whittier where we board the **Island Princess** for a 6 day cruise past the Hubbard Glacier through Glacier Bay to Skagway. Then on to Juneau, Ketchikan, down the Inside Passage ending in Vancouver. The price for this trip is \$3,040 which includes round trip airfare from Boston.

In October, we travel to the **Imperial Cities** of Prague, Vienna, and Budapest. We start with 3 days in Prague and see the Hradcany Castle, St Vitus Cathedral, the Charles Bridge, and the Old Jewish Quarter. Then on to Vienna for the Schroenbrunn Palace, St Stephen's Cathedral, a cruise on the Danube and Melk. Our final 3 days are in Budapest for a Hungarian Horse Show and visits to the Mathias Church, the Fishermen's Bastion, Heroes Square, Szentendre and Visegrad. The price for this trip is \$3,149 including airfare from Boston.

We are also working on an 8 day summer trip to America's Music Cities of New Orleans, Memphis and Nashville with details available by April 2011.

Please note that reservations for the October 2011 **Discover Tuscany** trip close on 14 April 2011. A deposit of \$250 for each traveler is required with your reservation.

Upcoming “Bills of Interest”

The following newly introduced bills have MOAA's endorsement.

- H.R. 237 (Rep. Connolly, D-VA) would let DoD expand the period of eligibility for the homeowner assistance program (HAP) for members of the Armed Forces reassigned during the mortgage crisis
- H.R. 493 (Rep. Jones, R-NC) would authorize survivors of retired service members to keep the full retired pay amount for the month in which the member died (currently, the amount is recouped from the bank account, and the survivor later receives pro-rated payment only for the days the retiree was alive)
- S. 146 (Sen. Baucus, D-MT) would provide a \$2400 tax credit to employers who hire a veteran who has served over 180 days of active service in the last 5 years
- S. 260 (Sen. Bill Nelson, D-FL) would repeal the SBP/DIC offset and allow survivors to receive both their survivor benefit plan annuity from DoD and their dependency indemnity compensation from the VA
- S. Res. 17 (Sen. Inouye, D-HI) to designate the month of November 2011 as "National Military Family Month"

Coburn Protects the People

Senator Tom Coburn (R-OK) sent a letter to the Joint Chiefs of Staff this week calling on the Pentagon to improve the transparency of its bookkeeping by providing auditable financial statements. Dozens of GAO, DoD Inspector General and other reports over the last decade and more have repeatedly found that Pentagon books are so fouled up as to be “unauditable”, and that DoD can't identify how billions have been spent on a wide range of programs.

Coburn's letter said improved bookkeeping could produce savings that might otherwise come at the expense of military personnel programs. To create pressure on Pentagon leaders to making these changes, Coburn proposed freezing the defense budget for all non-military personnel accounts until DoD complies.

MOAA has repeatedly cited these same reports as ironic evidence that the Defense leaders who feel such urgency and determination to shift more costs to military people and families seem so uninterested in ending the well-documented waste of hundreds of billions of dollars by its own incompetent management practices
