MOAA-NH Chapter Holds its Annual Meeting/Luncheon at the Nashua Country

On Saturday, 8 November, at 1000 hours, the NH Chapter of MOAA conducted its annual business meeting at the Nashua Country Club followed by a short Board of Directors Meeting, then a celebratory luncheon that included the induction of both new Directors and Officers by our luncheon speaker.

Twenty-five members were able to attend the annual business meeting and listen to members of the Board of Directors and other members discuss the activities of the Chapter over the past year as outlined in the 2025 Annual Meeting Reports. Of note, the meeting minutes of last year's event had no comments or corrections and were approved by all present. The Treasurer/Bookkeeper reported that the Chapter was solvent, and the Trustee of the Trust Funds reported significant gains in our assets for the last year. Also, a proposed 2026 Operating Budget was presented. All three of these reports were approved by the attendees. Bill Luti reported on state legislative activities and the need for chapter members to participate in MOAA National's Legislative Action Center (see his separate article). An extensive report from the NH State Department of Military Affairs and Veterans Services (DMAVS) was presented which also included a two page handout of NH Veteran Resources which can be accessed at: NHVeterans.NH.Gov.

As he does each year, our Secretary gave an extensive breakdown of our current membership of 500 members which includes 129 surviving spouses. He also noted that membership has continued to decline each year since 2003

from a high of 1073 in 2003 to our current level of 500 this year. As a result, he proposed at the October Board of Directors (BOD) meeting that the Chapter consider reducing the number of Directors from our current level of 12 to 9 over the next three years as it has become more difficult to find volunteers to fill vacancies. This recommendation was approved by the BOD and presented at the annual meeting for discussion and a vote. This recommendation didn't receive a "second" at the meeting, and after an extended discussion, an alternative proposal was offered by Peter Burdett to delay this decision for one year as all current Director positions had been filled this year. This proposal was seconded and approved by all present.

Another important discussion was the recent decision of Martin's Point to withdraw from NH for the Medicare Advantage Program for 2026 affecting about 8,000 veterans in NH, primarily in the southern counties. Brenda Pennells, the Maine Chapter President and, until recently, an employee of Martin's Point, gave an extensive explanation to why Martin's Point and several other insurance companies made this decision.

The final action of the business meeting was to approve the slate of four Directors for full 3-year terms. The slate, which included CDR Peter Burdett, USN (Ret), Col Charles Frost, Jr. USAF (Ret), Maj Jason Moody, USA (Ret), and CPT Hollie Noveletsky, ARNG, was approved and the business meeting concluded at 1120 hours. A brief BOD meeting was convened immediately after the business meeting to elect the officers for 2026. Nominated and elected were: President, Lt Col Laurance Miller, USAFR (Ret); Vice-President, CWO4 Robert Jaffin, USN (Ret); (Cont. on Page 4)

North Star

I recently attended the MOAA Eastern Training at Hershey Resorts, Pennsylvania. There, we had many breakout sessions. However, I would like to focus on the Communications breakout. It was very enlightening, with General Kelley, MOAA President and CEO, in attendance. The General emphasized that MOAA's "North Star" (Polaris) is supporting earned benefits. I paraphrase from MOAA's Mission statement, "...**preserve and protect earned benefits for our uniformed services, veterans, their families, and surviving spouses through advocacy, leadership, education, and service...**". And, that "we are an organization of officers, but not about officers." Our own By-Laws underscores these ideals in our Preamble and Purpose, to 1) promote purpose and objectives of MOAA, 2) foster fraternal relations, 3) protect rights and interests, 4) provide useful service, 5) to serve the NH community.

So, why am I stating the obvious? To remind and highlight why we exist as an organization of officers. With that in mind, I want to expand those thoughts as to what we are and what we are not.

As we all know, there have been many events in the recent past that have directly impacted our views and perceptions of the military, the organization that we all love and have devoted a good portion of our lives to. Yes, we are still US citizens. However, in our current role, as stated above, we exist in a very narrow band of the military environment. And as such, we do not stray outside those perimeters. Why is that? Well, for one, we are a 501(c)(19)IRS organization, tax exempt nonprofit specifically designed to benefit US veterans. But, it also allows us to lobby our CODELS. To inform them, and focus on specific legislation that will benefit veterans and active duty. To maintain that status, MOAA and MOAA-NH must, at all times, follow these 501(c)(19) guidelines or risk losing our tax exemption, and thus our influence. As MOAA and MOAA-NH members, we must, at all times, abide by these guidelines. But, as I have stated, we are still US citizens. In that role, your free expression is guaranteed.

MOAA-NH has built a collegial and warm relationship with our four CODELs. Each of them have enthusiastically supported MOAA Key Legislative issues. They have welcomed our support and advice, at all times. In many instances, they have sought out our input and advice on many issues. And, on their own, have supported NH veterans with many of their own legislative bills.

As your President, I will confine my focus and direction to the stated MOAA Mission (above) and MOAA-NH By-Laws at all times. I will not stray from that "North Star". And if I do, I welcome your comments and suggestions.

I have said a great deal here and I have said nothing new that has not been codified in our organization. I hope you all understand. And I welcome any thoughtful discussion you might have on this topic.

On to a more lighter topic, the upcoming Holidays. God bless you all in this joyous and blessed season. Merry Christmas and Happy Hanukkah. At one time or another, we as military members, have been away from family and friends during the holidays. Our first President, and first US Officer, George Washington, celebrated the 1776 Christmas Eve by crossing the Delaware River, leading the Continental Army and defeating the Hessians at the Battle of Trenton. It inspired hope in Americans and rejuvenated their spirits. But, there were two other crossings planned that never were implemented due to deteriorating weather. These events were preserved by the 1951 Emanuel Leutze painting.

Treasurer/Bookkeeper, CDR Peter Burdett, USN (Ret); and Secretary, CDR Michael McLean, USN (Ret). Immediately following this election, all adjourned to take part in the truncated Happy Hour!!!

Promptly at 1200 hours, eighty-one attendees assembled in the dining room and our President, Larry Miller, called the annual luncheon to order and the Pledge of Allegiance was led by Peter Burdett. Larry then provided an invocation followed by the National Anthem. Larry then recognized special guests including Senator Hassan, who was unable to attend, Betty Tamposi, Congresswoman Goodlander's mother, Kevin Galeaz who also was unable to attend, and Brenda Pennells, President of the Maine Chapter. Betty Tamposi then read a letter from Congresswoman Goodlander. Pat Miller, our Surviving Spouse Liaison spoke to recognize our surviving spouses: Gerry Wall, Barbara Donahue, Peter Burdett, Brenda Pennells, Gwen Devoe, Mary Webber, and Margaret Garneau who were all seated at a special table at the front of the room. Pat also mentioned some resources that are available on MOAA.org for use by surviving spouses. Again, Larry made some brief comments about the MOAA Legislative Action Center and its importance to both MOAA National and the Chapter. He also mentioned that the MOAA-NH granite bench has finally been installed at the NH State Veterans Cemetery! Due to the winter conditions, we will probably have a formal



dedication ceremony later in the spring. At this point, Congressman Chris Pappas had arrived and made a few comments. He had been in Dover at a bridge dedication & commemoration ceremony for Capt Jack Casey, USMC, who had been killed in 2024 in a training accident. He also made some comments about the ongoing government shut-down and his hopes of it ending soon and for ways to

prevent future shut-downs. He also mentioned that Congress is working to get a full-service VA Hospital in NH and are awaiting the results of the feasibility study which led to a remodeling of the current facility or a new facility. They are also continuing to work on the PACT Act implementation and assisting veterans in connecting them with care and benefits. They are also working on MOAA initiatives including meeting the needs of military spouses in the workforce, the concurrent receipt issue involving both military retirement and disability benefits. Other activities include veteran homelessness, mental health challenges, and to prevent veteran foreclosures, and a partial claims program. Following Congressman Pappas's comments, the President introduced all new members to MOAA-NH who were present at the luncheon. A list of all deceased members during the last year was present on each table and a moment of silence was taken to remember these deceased members and TAPS was played.



The President then asked our guest speaker, Colonel John Gargus, USAF (Ret) to perform the installation of all the new



Directors and Officers of the Chapter. Colonel Gargus then administered the oath of office to those assembled. Unfortunately, both CWO4 Robert Jaffin, USN (Ret) and Maj Jason

Moody, USA (Ret) were unable to attend the luncheon and will be installed at a later date.

After a wonderful luncheon, the President formally introduced our guest speaker, Colonel John Gargus, USAF (Ret), who was commissioned as a 2d Lt from the AFROTC Unit at Bowling Green University. He completed navigator training and crewed a C-118 Liftmaster and served as the lead navigator of the SonTay raid to rescue American POW's held in a camp 23 miles outside of Hanoi, North Vietnam on 21 November 1970.

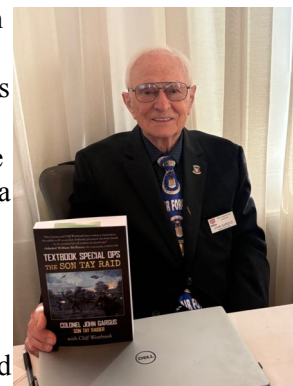

As a result of his actions for this mission, he was awarded the Silver Star. Colonel Gargus was born in Velka Poloma, Czechoslovakia, and escaped with the assistance of his parents in 1949 to join his grandmother in the United States. He retired from the USAF in 1983 after a 27-year career and his final assignment on active duty was as Chief of USAF Mission, Columbia. He was inducted into the Air Commando Hall of Fame in 2003 and he currently lives in Manchester. He previously authored a book called, “The Son Tay Raid: American POW’s in Vietnam Were Not Forgotten”. He discussed his current book, just released in September, “Textbook Special Ops: The Son Tay Raid”, for the audience today. He went into great detail about the attempts of the US to rescue these POW’s and the virtually unknown role played by the US Navy in a vast attempt to deceive the North Vietnamese on the actual target of the operation by conducting extensive decoy air operations in the South China Sea. The secrecy in this operation was so great that the US Navy operations were not revealed for many years, but it also resulted in a several month loss of actual intelligence as to the activities around the POW camp prior to the raid. As a result, when the raid was successfully conducted, none of the POW’s were found as they had been moved to a new location sometime before the raid. Although unsuccessful, the raid attempt so stunned the North Vietnamese that they consolidated all POW’s into the “Hanoi Hilton” in the capital.
