## This Memorial Day, We Honor Those Who Courageously Gave Their Lives

*May 28, 2021: A message from MOAA's president, Lt. Gen. Dana T. Atkins, USAF (Ret), on taking time to remember.*

Last year, many Memorial Day messages echoed now-familiar themes of "uncertain times" – passages of hope in the face of uncertainty, of national pride in a time of crisis.

This year, I want to share with you other stories – those of MOAA members who have honored their brothers and sisters in arms.

Stories like that of Col. Frank Plummer, USA (Ret), who served in three wars and in retirement, inspired by the patriotism shown by his than 470 miles of U.S Highway 26 as the state's official POW/MIA Memorial Highway. The move, supported by fellow members hometown, designed and raised funds for what's now the Veteran's War Memorial of Texas. Marked by a 105-foot granite spire, the memorial honors those who've made the ultimate sacrifice.

Or that of Lt. Col. Dick Tobiason, USA (Ret), who spearheaded efforts to dedicate more of MOAA's Central Oregon Chapter, honors about 2,000 of that state's servicemembers who either spent time as prisoners of war or remain listed as missing in action, some dating back to World War I.

And while these actions of MOAA members show true dedication to the "Never Stop Serving" mantra, they are far from isolated incidents. Nationwide, patriots of all stripes pay tribute to those who didn't return home – whether it's the laying of a wreath, a visit to a friend or

family member's final resting place, even a simple moment of silence and contemplation on the sacrifices of the few to benefit the many.

This Memorial Day, join their efforts. This is not an "uncertain time" – it is one of acknowledgement, of thankfulness, of pride in service, of tenets held dear by those who've served throughout the centuries.

It has been a long time coming, but we finally have lots of good news to share.

We had a great turnout for the belated Granite State Warriors Awards at the Common Man in Plymouth. The weather cooperated, the venue was excellent, the food and service were both top rate. We were also able to do everything on schedule so everyone was able to leave at a reasonable time for a beautiful springtime drive home.

As I am sure everybody is aware, both CDC and state guidelines have begun changing and easing up. As a result, we should be able to move closer to normal activities and a more normal MOAA-NH schedule.

Right now, our next confirmed major event is the clambake, which has now moved to September 18 back on Jamaica Island at the Portsmouth Naval Shipyard.

The Board of Directors will hold its regular dinner meeting at the Red Blazer in Concord on July 8 at 6 pm. You do not have to be a member of the Board to join us. However, the seating in this meeting room is limited, so please contact me or Michael McLean in advance if you would like to join us.

I have spoken with the people at Mount Washington Cruises; and if it all possible, we will try to organize a weekday brunch sailing sometime in July. There seemed to be quite a bit of interest in this idea from those I was able to speak with at the last luncheon, so I will pursue this. Right now, the MS Mount Washington itself is out of service for maintenance. It will probably be sometime after June 1 before we can begin making arrangements.

The Strategic Initiative Committee held a meeting at Wayne Balcom's house on Saturday, May 22. Members of that committee are doing an outstanding job. They will share their results with the Board of Directors later this year and recommend a number of changes at the Annual Meeting in November.

Peter Burdett and I have been working the new Advocacy In Action Program, which has replaced Storming the Hill. We have already met with half the delegation and have found overwhelming support for MOAA's primary issues this year as well as growing support for the new commissary at Pease. The small Coast Guard Commissary at South Portland has closed, so the Southern Maine Chapter of MOAA will also be working with their delegation to get a commissary at Pease. Peter and I will meet very soon remotely with Senator Hassan's staff in Washington, DC. We also plan to meet remotely with Congresswoman Kuster's DC staff on June 15. More information to follow.

We still have a number of ideas we are reviewing for activities between now and the Annual Meeting. Don't be surprised if you see some emails, postcards, or flyers with wonderful news.

As always, stay safe and find new and exciting ways to enjoy late spring and summer in New England.


