# MOAA-NH Presents the Annual Granite State Warrior Awards for 2022!

After a few days of nice, mild February weather, the temperatures again dropped as we prepared to celebrate

our annual Granite State Warriors award at the Nashua Country Club on February 18th. Although these awards were started in 2011, this is only the 11th time this award had been presented due to the



pandemic shutting down virtually all social activities in 2021 and 2022. Fifty-seven attendees, including guests and speakers, were present to see and hear Phil and Julie Taub, Co-Founders of "Swimming With a Mission, Inc." receive this year's award. After an enjoyable hospitality hour, President James LeFebvre introduced Senator Maggie Hassan who read a prepared statement praising the work of the Taub's on behalf of Granite State veterans. She mentioned that "Swim with a Mission" began as a fund raiser across Newfound Lake about six years ago to help veterans transition to civilian life, and now includes helping veterans obtain service dogs as well as starting a new initiative, "Arts with a Mission" for art therapy programs at locations such as Walter Reed National Military Medical Center. Other featured events that the Taub's have started include a huge Veterans festival held at Northeast Delta Dental Stadium, a unique team building day led by the US Navy SEAL's, and they recently added a new event, "Green Beret With a

Mission" challenge with the help of Camp Resilience. Senator Hassan went on to mention various recent legislative issues that have been passed in Congress including the new PACT act and a "988" veteran suicide hotline. Congressman Chris Pappas was unable to attend, but sent a representative to add his congratulations to the Taub's for all their efforts on behalf of Granite state veterans. Following these tributes, the Country Club staff served an outstanding luncheon to all present.

After lunch, our President gave a brief history of the Granite State Warrior award, originally conceived by Bruce Avery, which was designed to recognize NH based organizations that enhanced the warfighting abilities of US forces or improved the health, morale, and welfare or



recognition of US military personnel or their families through the creation of services in the US, or for deployed military personnel, designed to improve the quality of life for these forces and their families. The President then gave a brief recounting of past winners of this award. At this point, the President invited Phil and Julie Taub to the front of the dining room where he recounted their various efforts for veterans over the past six years. During this time, they have raised over \$10 million dollars

to support veteran needs and brough together over 40 veteran service organizations to work on the issues that face veterans in NH. They published a book about NH's veterans in 2022. Lastly, they have instituted a "Never

(Continued from page 1) Forget" campaign to remember the 94 souls that NH has lost since the start of the "War on Terror". This is a testament to their ability to include and grow their support for NH Veterans. Phil Taub then took the microphone and thanked the Chapter for this award on behalf of himself and Julie. He explained that although they did not serve themselves, they have learned a-lot

about veterans during their journey. When they started "Swim With a Mission", they wanted to support veterans in the lakes region and only expected to raise \$25,000 initially. They met some Navy



SEALs and convinced them to participate. To their surprise, 1500 people showed up and they ended up raising \$450,000 from that event. When they started to give out the money, they started to learn something about the Veteran Service community. There were gaps in what the various Veteran Service organizations were doing, and they realized that with almost 100,000 veterans in state, there were no outpatient therapy programs available. They began teaming up with the VA, Veterans Count, the state

of NH and donated \$740,000 to the Currier Museum to create a dedicated outpatient art therapy there. A similar issue arose with Liberty House and homeless veterans in the state, which now number less than 100 in state.

They donated \$1million to Liberty House while Catholic Charities donated \$500,000 to expand that space. Last year, they raised \$2 million and focused on veteran suicide by focusing on housing, service dogs, and educating the public. By joining forces with Governor Sununu, Easter Seals, and Alex Ray who donated property in Franklin, NH, they were able to leverage \$23 million for affordable housing for all veterans and provide a single point for all of the VSO's can have a presence. The VA is planning to move its Tilton CBOC to this new campus. Finally, they've organized an annual summit for the VA and all VSO's to share information and resources. After his talk, President LeFebvre presented Phil and Julie with Chapter Challenge coins, the official award certificate, and inducted them as "honorary members" into the NH Chapter of MOAA.

#### Dear Secretary McDonough:

We write to urge you to address the extremely concerning infrastructure failures at the Manchester Veterans Affairs (VA) Medical Center and other VA facilities in New Hampshire. The VA facility in Manchester continues to suffer from infrastructure-related problems that have significantly reduced its capacity to treat veterans. Last week, for example, water and heating concerns required patients in the Community Living Center to be relocated to other facilities and in-person appointments had to be cancelled. While we commend the staff at the facility for continuing to provide the best possible care to veterans, we urge you to prioritize improvements to this facility and a full-service VA hospital in New Hampshire. We also request that you brief us on your progress as soon as possible.

It is well documented that VA facilities across the country are struggling with upkeep of their aging facilities and infrastructure. While the Manchester VA Medical Center is 73 years old, according to recent studies, the average VA facility is 60 years old, five times older than than the average building age of United States Senator not-for-profit hospital systems in the United States (1). The facilities are also in poor condition. One study estimated that VA would need two to three times its current expected funding levels to maintain its facilities and meet projected growth needs (2). Aging infrastructure can reduce veterans' access to high quality healthcare, negatively affect the morale and effectiveness of VA's health care providers, and discourage some eligible veterans from seeking VA care.

The VA is also struggling with a growing maintenance backlog. The agency is attempting to balance daily upkeep with a need to 3. Nicole Ogrysko, As VA plans to modernize aging facilities, it faces a completely modernize facilities. In 2021, the VA estimated that it would need \$22 billion to address poor and failing conditions at VA facilities (3). Some of the main challenges faced by the agency are the these older building are not set up to support new and challenging technologies that are necessary to deliver the best care to patiets.

Dr. Shareef Elnahal, the Undersecretary of Veterans Affairs for Health, said in December 2022 that the VA would submit its updated infrastructure plan to Congress in the first half of calendar year 2023. We look forward to seeing this plan. Dr. Elnahal stated that the VA will focus more on new construction than on current infrastructure upkeep. It has long been our position that one of those needed construction projects should be a full-service VA hospital in New Hampshire.

Whether or not New Hampshire ultimately gets a full-service VA hospital, we strongly urge you to prioritize urgent maintenance of the Manchester VA Medical Center in the updated infra-structure plan. In 2017, a water pipe burst in the Manchester VA Medical Center closing the operating room for months and cost-ing the VA millions of dollars to repair. On November 26, 2022, a different pipe burst in the facility that caused damage and flood-ing on the second, third, and fourth floors and forced the operating room to close for months again. Half of all appointments had to be cancelled or converted to telehealth. Finally, over the weekend of February 3, 2023, historic arctic temperatures were recorded in New Hampshire. In-person appointments at the Manchester VA Medical Center were cancelled due to water and heating concerns at the facility. Both the Community Living Center and long-term care unit had to be evacuated. In addition, the facility suffered another burst pipe in part due to the extreme weather. These are just some of the examples that highlight the ongoing problems and the critical need for a full-service hospital in New Hampshire.

We respectfully request a joint meeting with you to discuss the specific problems at the Manchester VA Medical Center and talk about the much-needed improvements to the infrastructure and modernization of all VA facilities in New Hampshire.

Thank you for your time and willingness to meet and discuss these urgent matters.


